## Polar Plunge Waiver and Release Agreement

**Please read carefully, this is a release of liability and waiver of legal rights.**

In consideration of my being permitted to participate in the Frozen Dead Guy Days Polar Plunge (hereafter referred to as "the Event"), I agree to the following waiver and release:

I understand that these risks, hazards and dangers include without limitation:

(2) risks involved in standing and moving about on frozen lakes and reservoirs and on snowy, icy, or irregular terrain;
